
A RESOLUTION AUTHORIZING THE MAYOR
TO ENTER INTO AN AGREEMENT WITH THE
BOYS AND GIRLS CLUBS OF BINGHAMTON
FOR FY44 AND FY45 CDBG FUNDING IN AN
AMOUNT NOT TO EXCEED \$20,000 FOR THE
TEEN CENTER PROGRAM

WHEREAS, the City of Binghamton wishes to enter into an agreement with the Boy and Girls Clubs of Binghamton, for Fiscal Year 44 and 45 Community Development Block Grant funding in an amount not to exceed \$20,000 for the Teen Center Program.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the Boys and Girls Clubs of Binghamton for Fiscal Year 44 and 45 Community Development Block Grant funding in an amount not to exceed \$20,000 for the Teen Center Program; and that funds shall be deducted from budget lines: (i) \$7,694.22 CD7310.533516 (Youth Programming), (ii) \$5,070.49 CD8676.53315.CDY44 (Human Services), and (iii) \$7,235.29 CD710.533516.CDT45 (Youth Programming) for this purpose.
