A RESOLUTION AUTHORIZING THE CITY OF BINGHAMTON POLICE DEPARTMENT TO USE AWARDED FUNDS TO IMPLEMENT THE GIVE VI INITIATIVE AND FUND ASPECTS OF THE SOUTHERN TIER CRIME ANALYSIS CENTER

WHEREAS, the City of Binghamton is eligible for the GIVE VI Grant, in the amount of \$231,285 to be used for the crime reduction initiative that helps the City of Binghamton Police department in their efforts to stop violent crime; and

WHEREAS, the GIVE VI Grant is reimbursable; the grant funds will be administered by the Chief of Police or his designee; and the estimated date of completion will be June 30, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, as may be necessary to accept GIVE VI Grant, in the amount of \$231,285 to be used for the crime reduction initiative that helps the City of Binghamton Police department in their efforts to stop violent crime; and be it further

RESOLVED that there is no City match for the acceptance of such funds; that the Chief of Police or his designee shall be the grant project administrator; and that the estimated date of completion will be June 30, 2021.
