A RESOLUTION AMENDING PERMANENT
RESOLUTION 12-81, REGARDING FUNDS
FROM THE COMMUNITY CAPITAL
ASSISTANCE PROGRAM FOR THE DESIGN
YOUR OWN PARK INITIATIVE

WHEREAS, the Council of the City of Binghamton adopted Permanent Resolution 12-81, on November 7, 2012, entitled, "A Resolution Authorizing the Mayor to Apply for and Accept up to \$100,000 from the Community Capital Assistance Program for the Design Your Own Park Initiative"; and

WHEREAS, the funds were to be used to purchase a portable stage and fund improvements at up to three parks associated with the Design Your Own Park Initiative; and

WHEREAS, in order to expedite construction of the Spray Park at Columbus Park the remaining funds after purchasing a portable stage will be used for such construction; and

WHEREAS, Community Development Block Grant (CDBG) funds from prior years will be used at an amount not to exceed \$45,000 to fund improvements at three other parks associated with the Design Your Own Park Program.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE, that City Council does hereby approve and endorse the amendment, using \$100,000 from the Community Capital Assistance Program to purchase a portable stage and to fund construction of the Spray Park at Columbus Park, while using CDBG funds from prior years at an amount not to exceed \$45,000 to improve three parks associated with the Design Your Own Park Initiative.
