WHEREAS, the City Engineer has recommended entering into Supplemental Agreement No. 2 with the New York State Department of Transportation for design services for Front Street Reconstruction at Clinton Street, in an amount of \$90,000; and

WHEREAS, the \$90,000 is 100% reimbursable through the Highway Safety Improvement Program; and

WHEREAS, current funding for the project is available from budget line H5120.525023.51809 (Bridge Maintenance, Norfolk Southern, Bond Issue of 05/19/2009).

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular sessions, does hereby:

RESOLVE, that the Mayor, or his designee, is hereby authorized to enter into Supplemental Agreement No. 2, approved as to form and content by the Office of Corporation Counsel, with the New York State Department of Transportation for the purpose of accepting \$90,000 from the Highway Safety Improvement Program for design services for Front Street Reconstruction at Clinton Street, and be it further

RESOLVED, that current funding for the project is available from budget line H5120.525023.51809 (Bridge Maintenance, Norfolk Southern, Bond Issue of 05/19/2009).
