





Impact: This project will be increasing the impervious area of the project site. The site will be going from an open green space to a large interactive play facility targeted towards handicap accessibility. This includes the construction of pathways, play areas, game area, seating, and recreation space.

Importance of Impact: The importance of this impact is very insignificant. Even though this project will be altering a large area of the park it will have little impact on erosion or stormwater runoff because the City of Binghamton has had a full Stormwater Pollution Prevention Plan (SWPPP) developed for this project. The City of Binghamton has contracted Keystone Associates, Architects, Engineers and Surveyors, LLC to develop the SWPPP for this project. Through the development of the SWPPP, Green Infrastructure techniques have been designed to mitigate all runoff from this site to keep runoff to per-developed natural conditions. A Sediment and Erosion Control plan has also been developed to prevent erosions during construction. This project is taking place on a large geographical section of the park, 2.1 acres, with a disturbed area of 1 acre. But the Green Infrastructure will keep runoff levels to existing condition levels. There is a very low probability of any impact occurring because the SWPP has been designed to mitigate the impact. There will be no impact to the public.


