ORDINANCE

AN ORDINANCE AMENDING THE CODE OF THE
CITY OF BINGHAMTON §127-11.C.(1), THRESHOLDS
FOR CONTRACT AWARDS AND TO CORRECT THE
LETTERING

WHEREAS, the Code of the City of Binghamton §127-11, *Professional services and consultants, C, Thresholds for contract awards*, (1) provides, "City Council must approve any contracts for professional services exceeding \$5,000; provided, however, that during any calendar year where the cumulative amount of professional service contracts awarded by the Board of Contract and Supply equals \$50,000 or more, the threshold drops to \$1,000 for City Council approval of additional contract, unless otherwise permitted"; and

WHEREAS, based on increases in both the number and amount of professional service contracts over the years, the Board of Contract and Supply and the City's Purchasing Agent have requested Council to amend the individual contract amount from \$5,000 to \$10,000 and the cumulative amount form \$50,000 to \$60,000; and

WHEREAS, the lettering in §127-11 skips "D" and should be corrected.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That Code of the City of Binghamton §127-11, *Professional services and consultants, C, Thresholds for contract awards* C.(1) is deleted and is replaced as follows:

City Council must approve any contracts for professional services exceeding \$10,000; provided, however, that during any calendar year where the cumulative amount of professional service contracts awarded by the Board of Contract and Supply equals \$60,000 or more, the threshold drops to \$1,000 for City Council approval of additional contracts, unless otherwise permitted.

Section 2. That the lettering be corrected by the City Clerk and Corporation Counsel.

Section 3. That this Ordinance shall take effect immediately.
