**AN ORDINANCE AMENDING CHAPTER 391,
TREES AND SHRUBS, SECTION 391-2 SHADE
TREE COMMISSION-CREATED**

WHEREAS, the Code of the City of Binghamton, Chapter 391, *Trees and Shrubs*, §391-2, *Shade Tree Commission-created*, provides for appointment of members of the Shade Tree Commission; and

WHEREAS, the Mayor has requested amending §391-2 to eliminate one of the Mayor's appointments and to replace said appointment with the Commissioner of Parks and Recreation or his/her designee as member of the Shade Tree Commission.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1: That the Code of the City of Binghamton, Chapter 391, *Trees and Shrubs*, §391-2, *Shade Tree Commission-created*, is hereby repealed and replaced in its entirety as follows:

There is hereby created a City Shade Tree Commission for the City of Binghamton, County of Broome, State of New York. Said Commission shall consist of seven (7) members, who are residents or work in the City, three (3) who shall be appointed by the Binghamton City Council Parks and Recreation Committee and three (3) who shall be appointed by the Mayor of the City of Binghamton, and one (1) who shall be the Commissioner of Parks and Recreation or his/her designee.

Section 2. That this ordinance shall take effect immediately.


