**ORDINANCE**

AN ORDINANCE AMENDING THE 2016  
BUDGET TO INCREASE INSURANCE  
RECOVERIES REVENUES AND DEMOLITION  
EXPENSES BY \$45,000 TO PAY FOR  
DEMOLITION OF 162 HENRY STREET

WHEREAS, 162 Henry Street recently sustained significant fire damage and the Supervisor of Building Construction, Zoning, & Code Enforcement has determined that the building endangers the health, safety, or welfare of the public and must be demolished; and

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2016 budget to increase insurance recoveries revenue and demolition expenses in the amount of \$45,000 to pay for said demolition; and

WHEREAS, the City intends to recover the cost of demolition from the property owner or the property owner's insurance carrier; and


WHEREAS, the proposed budget amendment was approved by the Board of Estimate and Apportionment on May 27, 2016.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2016 budget to increase revenue budget line A.42680 (Insurance Recoveries) and expense budget line A1364.54470 (Demolition) both in the amount of \$45,000 for demolition of 162 Henry Street.

Section 2. That this Ordinance shall take effect immediately.
