A RESOLUTION AUTHORIZING THE MAYOR
TO RENEW SCHOOL RESOURCE OFFICER
AGREEMENTS WITH THE BINGHAMTON
CITY SCHOOL DISTRICT

WHEREAS, the City of Binghamton ("the City") wishes to renew two School Resource Officer ("SRO") Agreements with the Binghamton City School District ("BCSD"), whereby the City agrees to provide the BCSD with one (1) Police Officer at the Binghamton High School and two (2) Police Officers at the Middle Schools, and the BCSD will pay the City for providing such SROs; and

WHEREAS, such agreements are ratified and effective for the 2015/2016 school year.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into a renewal School Resource Officer Agreement, approved as to form and content by the Office of Corporation Counsel, with the Binghamton City School District, and that such agreements are ratified and effective for the 2015/2016 school year.
