
A RESOLUTION AUTHORIZING THE MAYOR
TO AMEND THE CURRENT ESG CONTRACT
WITH CATHOLIC CHARITIES OF BROOME
COUNTY FOR THE TEEN TRANSITIONAL
LIVING PROGRAM USING UNSPENT OLDER
ESG FUNDS TO INCREASE THE CONTRACT
BY AN AMOUNT NOT TO EXCEED \$5,431

WHEREAS, the City of Binghamton wishes to amend the current contract with Catholic Charities of Broome County for the Teen Transitional Living Program and increase the funding with older unspent Emergency Shelter Grant ("ESG") in an amount not to exceed \$5,431.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized into an agreement, approved as to form and content by the Office of Corporation Counsel, with Catholic Charities of Broome County for the use of unspent older Emergency Shelter Grant ("ESG") funding in an amount not to exceed \$5,431 and that funds shall be deducted from budget line CG6142.533999.CGY41 (ESG – Sunset).
